The District Court of Vratsa certifies that on the grounds of the Law on Non-Profit Legal Entities, by decision of 16.12.2014, the latter registered the last amendment of the batch in the Register of the Non-Profit Legal Entities, field under No. 30, Volume 2, p. 128 as per the Company Case No. 32/2010 – an association with a public benefit activity named **'Syndicate of Atomic Energy- Legality, Responsibility, Morality, Commitment'**, having their headquarters at - Kozloduy, House of the Energy Worker, **objective:** to defend and protect the fundamental social and labor interests and rights of its members in the field of labor, employment and labor relations, social and health insurance, support, ensuring a high standard of living and professional realization in compliance with the Constitution of the Republic of Bulgaria, the legislation in force, the conventions of the international labor organization and other international agreements to which the Republic of Bulgaria is a party, **means of achieving the objectives:** leading negotiations and concluding agreements with employers, employers' organizations and executive bodies, concluding collective agreements with employers, provision of trade-union protection in the field of employment, labour and insurance relations and the rights of the individual, affirming the equality of contract workers and employees before the law, the state and the employers, protection of the right to work of all the Syndicate's members, regardless of profession, qualification, rank, age and sex, aiding to ensure a level of income per family member, sufficient for a dignified existence, protection of women as mothers and educators of their children, ensuring freedom in choosing whether, when, where and what to work, organisation of trade-union solidarity events and protest actions, provision of financial, legal and trade-union support to its members, study and adaptation of labour and social legislation to the standards and practices of the European Union, development of national and international programmes and projects in the sphere of industrial relations, social security, employment, qualification and re-qualification, income and standard of living, development of human resources and social integration, establishment and maintenance of relations with similar syndicates in Bulgaria and abroad, cooperation for exchange of experience and mutual assistance, participation in the work of national and international trade-union forums, representation and protection of its members before the employer, the executive and the judiciary, state and municipal administration, social, political and other organisations on labour-related, social and health insurance and living standards issues, posing requests to the employer to provide conditions for recreation of its members, carrying out cultural and educational activities, organizing and carrying out other activities deriving from this Statute. **Scope of activity:** Establishment of temporary or permanent expert working groups for analysis and preparation of draft legal acts, cooperation with political and public organizations in the country and abroad, public discussion of draft regulatory acts, cooperation with state authorities and employers to a degree, that does not
